

SECTION 3. COMPOSITION/INFORMATION ON INGREDIENTS

This product contains the following components and mixture of the following substances with non-hazardous additions.

Assay Buffer: 10 mL Liquid Non-hazardous. NAD Solution: 1 mL Liquid Non-hazardous. MTT Solution: 1.5 mL Liquid Contains 0.1-2% thiazolyl blue tetrazolium bromide (CAS #:298-93-1) Diaphorase: 120 μL Liquid Non-hazardous. Calibrator: 10 mL liquid Contains 50% Isopropanol (CAS #: 67-63-0) Substrate: 1.5 mL liquid Non-hazardous.

SECTION 4. FIRST AID MEASURES
