#### **SECTION 3. COMPOSITION/INFORMATION ON INGREDIENTS**

This product contains the following components and mixture of the following substances with non-hazardous additions.

Assay Buffer: 12 mL Liquid

Contains 0.5-5% Tris(hydroxymethyl)aminomethane (CAS#: 77-86-1)

LAA Enzyme: 120 µL Liquid

Contains 20% glycerol (CAS #: 56-81-5)

HRP Enzyme: 120 µL Liquid

Dye Reagent: 120 μL liquid

Contains 10-99% dimethyl sulfoxide (CAS#: 67-68-5)

## **SECTION 4. FIRST AID MEASURES**

Eye: Eye irritation. Flush immediately with large amounts of water for at least 15 minutes. Eyelids should be held away from the eyeball to ensure thorough rinsing. Get immediate medical attention.
