Contains 100% dodecane (CAS #: 112-40-3).

Lecithin: dried Non-hazardous.

High Permeability Control: 120 μL Liquid Contains 90-99% dimethyl sulfoxide (CAS#: 67-68-5). Medium Permeability Control: 120 µL Liquid Contains 90-99% dimethyl sulfoxide (CAS#: 67-68-5). Low Permeability Control: 120 µL Liquid Contains 90-99% dimethyl sulfoxide (CAS#: 67-68-5).
