SECTION 3. COMPOSITION/INFORMATION ON INGREDIENTS

This product contains the following components and mixture of the following substances with non-hazardous additions.

NAD/MTT: 1 mL Liquid Contains 0.1-5% thiazolyl blue tetrazolium bromide (CAS #:298-93-1) Enzyme A: 30 μL Liquid Non-hazardous.

SECTION 4. FIRST AID MEASURES
